A copy of your license **MUST** be submitted along with this application and your registration fee. Preference is given to vendors who register for two days. If we have room, we will try to accommodate vendors who want one (1) day and reserve the right to all the vendors who are there for the duration of the event.

The Tompkins Center Historical Society and the Township of Tompkins shall not be liable for any injuries, losses or damages sustained by any participant, his/hers/their heirs, successors, and assigns to any other person or organization arising out of this event.
